**THE ANNOUNCEMENT OF CHANGES IN PRE-QUALIFICATION DOCUMENT REGISTRATION

In connection with Secretary General of Ministry of Public Works and Public Housing No. UM.05.01-Sj/731 dated 10th September 2020 on Ministry of Public Works and Public Housing Office Operation in DKI Jakarta and announcement Number 09/KPBU/PPJR/IX/2020 dated 4th September 2020 and the enactment of Large-Scale Social Restriction in Jakarta (which causes offices to be prohibited from operating) starting on Monday, 14th September 2020, through this e-mail, we hereby notify you that the process of Request of Qualification (“RfQ”) document collection which **INITIALLY** was to be conducted in person, **SHALL BE DONE** electronically with the following requirements:

1. The Prequalification Candidate shall submit a request of RfQ document collection through e-mail address: pengadaanjalintim@pu.go.id
2. The Prequalification Candidate must meet the requirement for RfQ document collection as follows (a copy of electronic/scan of the documents below must be attached):
 - a. Submit a copy of proof which indicates the party is authorised to act on behalf of the legal entity or the consortium
 - b. Submit a power of attorney which indicate the party is authorized to act on behalf of the legal entity or the consortium and copy of article of association and notarial deed that stating the latest composition of the Board of Director or consortium agreement (if collection of the RfQ to be conducted through a proxy)
 - c. The Registrant shall submit a copy of his/her identity card/ identity document;
 - d. The Registrant shall not represent more than 1 (one) legal entity or consortium.
3. All documents required according to number 2 above, will be requested from time to time by the Procurement Committee and the Prequalification Candidates shall submit/show the original document to the Procurement Committee.

Registration and collection of Prequalification Documents starts on: **Date: 4th September 2020 – 17th September, 2020 (Working Days). Time: 09.00 - 16.00 WIB**
