Ministry of Public Works and Housing invites Business Entities to participate in the Pre-qualification stage of the Procurement of Project Company for the Replacement and/or Duplication of Callender Hamilton (CH) Bridge Public Private Partnership Project in Java Island ("Project"). The return of investment for the project company is to be derived from Availability Payments

The Project will be implemented under Presidential Regulation Number 38 of 2015 on Cooperation between Government and Business Entity in Infrastructure Provision, where this PPP project is initiated by the Business Entity (Unsolicited) which is PT Bukaka Teknis Utama Tbk with a right to match any other best offer (Right to Match). This Project is planned to be supported by Government Guarantee by PT Penjaminan Infrastruktur Indonesia (Persero).

The estimated investment cost of the Project is IDR. 2.355,08 Billion. The scope of the Project consists of financing, technical planning (Detailed Engineering Design for bridges), construction of bridges, operation and maintenance of the existing bridges during construction period, and operation and maintenance of the bridges after construction period. The concession period of Project is 12 years which consist of 2 years construction period and 10 year's service period.

To obtain the Request for Pre-qualification Document, the interested candidates must fulfil and submit the electronic/scanned copies of the following requirements:

1. Submit a copy of evidence which indicates that the party is authorised to act on behalf of the business entity or consortium;
2. Submit a power of attorney from the party that is authorized to act on behalf of the business entity or consortium along with copy of articles of association and notarial deed stating the latest composition of the Board of Directors or consortium agreement (if the collection of the Request for Pre-qualification Document to be conducted through a proxy);
3. The registrant must show his/her original identity card and submit its copy; and
4. The registrant shall not represent more than 1 (one) business entity or consortium.

The Procedures of Registration and collection of Pre-qualification Document by electronic means are as follows:
